Commissioner's Notes Meeting of 31 March, 2014

- 1. The 2013-2014 Youth Sector Calendar has been modified to bring back June 23rd as a regular school day as April 7th became a Ped Day due to the April 7th elections.
- The 2014-2015 Youth Sector Calendar has been modified to make November 28th a Ped Day instead of November 21st as the Palais des Congres altered the Teachers' Convention date.
- The current rental of facilities rates will be increased, effective July 1st, 2014, by 2% for the 2014-2015 year to reflect the increase in labour, energy and maintenance expenses.
- LBPSB has requested that MELS fund the November 2014 school elections through a specific supplementary allocation.
- 5. The document entitled Reporting of Financial Fraud and Misconduct Policy was adopted.
- 6. LBPSB will be creating a Wellness Policy.
- 7. CONSULTATIONS:
