Addendum #3 - Daycare

Daycare Notes - December 2014

<u>Budget:</u> The November Revised budget is being presented. Our staffing costs are exceptionally high due to the needs of many of the students both in the daycare and lunch program. We may need to consider removal of subsidies for the busses for ped day field trips. For the moment we are limiting the number of "out-house" ped days that require a bus, to be cost effective.

<u>Christmas Daycare Party:</u> We will be hosting a daycare Christmas party in the gym next Tuesday, December 16th. To have more control on the food, we have ordered Dominoes pizza for all the children and will decorate sugar cookies for dessert. The Karaoke machine will also be hooked up for entertainment.

<u>Christmas Cheer</u>: Mrs. Rivard will be serving hot chocolate and goodies at the daycare sign-in door to all the parents one day this week.

<u>Last Day of School</u>: The last day will be a full day for both the school and the daycare. Papers went out Monday, so parents could communicate with us their daycare needs on the last day.

First day in 2015: The daycare will be open as usual at 7:00am on Monday, January 5, 2014

<u>Outstanding Fees:</u> There is approximately \$25,000 in unpaid fees. A second reminder will be going out to all parents Monday, December 15, 2014. Daycare families with outstanding fees will be notified that daycare services will be suspended effective January 2015 until the outstanding fees are paid.

<u>Daycare Door:</u> A new system will be installed hopefully before Christmas which will include cameras and remote door openers. This will make the door work more smoothly as the outdoor door will be unlocked so parents can step out of the weather rather than waiting for an educator to open the door. The inside door will be locked. There will be a buzzer for parents to ring hooked up to a camera so the educator can see who it is, speak to the parent if necessary via intercom and call the child.
